Assignment of Invention

WHEREAS WE, Clément LANSALOT-MATRAS and Andrey V. KOROLEV, respectively, have invented certain new and useful improvements in "Heteroleptic (allyl)(pyrroles-2-aldiminate) Metal-Containing Precursors, Their Synthesis and Vapor Deposition Use To Deposit Metal-Containing Films" for which a provisional patent application was filed on July 22, 2011, having Application No. 61/510,857;

WHEREAS L'Air Liquide, Société Anonyme pour l'Etude et l'Exploitation des Procédés Georges Claude, a French corporation having offices at 75 Quai d'Orsay, F-75007 Paris, France, hereinafter referred to as "ASSIGNEE," desires to acquire from Clément LANSALOT-MATRAS the entire right, title and interest I have in and to said invention and in and to any Letters Patent that may be granted thereof in the United States and its territorial possessions and in any and all foreign countries;

I hereby authorize and request the Patent Office Officials in the United States and its territorial possessions and any and all foreign countries to issue any and all of said Letters Patent, when granted, to said ASSIGNEE as the assignee of the entire right, title and interest in and to the same, for the sole use and benefit of said ASSIGNEE, its successors and assigns, to the full end of the term for which said Letters Patent may be granted, as fully and entirely as the same would have been held by me had this Assignment and sale not been made.

Further, I agree that I will communicate to said ASSIGNEE or its representatives any facts known to us respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional, divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and generally do everything possible to aid said ASSIGNEE, its successors and assigns to obtain and enforce proper protection for said invention in the United States and its territorial possessions and in any and all foreign countries.

The undersigned hereby grants authorized representatives of the above identified ASSIGNEE the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
