AMENDED AND RESTATED
PATENT ASSIGNMENT

This AMENDED AND RESTATED PATENT ASSIGNMENT ("Agreement") dated as of March 28, 2012 by and between:

- (i) Rockstar Bidco, LP, a limited partnership organized under the laws of Delaware ("Assignor"), the address of which is Rockstar Bidco, LP, c/o Paul, Weiss, Rifkind, Wharton & Garrison LLP, 1285 Avenue of the Americas, New York, New York 10019-6064 USA, ATTN: Marilyn Sobel; and
- (ii) 2256355 Ontario Limited, a corporation organized under the laws of Ontario ("Assignee"), the address of which is 2256355 Ontario Limited, 295 Phillip Street, Waterloo, Ontario N2L 3W8 CANADA.

WITNESSETH:

WHEREAS, Assignor agreed to transfer certain assets of Assignor, including, without limitation, the patents, patent applications and provisional patent applications identified and set forth below;

WHEREAS, to effect such transfer, on or about February 29, 2012 (the "Effective Date"), Assignor and Assignee previously executed a Patent Assignment dated as of the Effective Date (the "Original Assignment") pursuant to which Assignor assigned to Assignee, and Assignee acquired from Assignor, all of Assignor's right, title and interest in and to the Assigned Patent Assets (as defined below); and

WHEREAS, Assignor and Assignee now wish to execute this Agreement in order to confirm the Original Assignment, to clarify certain details of Assigned Patents (as defined below) and to provide further evidence of the assignment to Assignee of all of Assignor's right, title and interest in and to the Assigned Patent Assets.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and agreements contained in this Agreement and for other good and valuable consideration the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

I. Confirmation and Assignment. Assignor hereby confirms that it has assigned to Assignee, and Assignee hereby confirms that it has accepted and acquired from Assignor (in each case, as of the Effective Date), all of Assignor's right, title and interest throughout the world (under any and all laws and in any and all jurisdictions) in and to the Assigned Patent Assets (as defined below). By way of further assurance, to the extent it did not already occur as of the Effective Date, Assignor hereby assigns to Assignee, and Assignee hereby accepts and acquires from Assignor (in each case, effective on the date of this Agreement), all of Assignor's right, title, and interest throughout the world (under any and all laws and in any and all jurisdictions) in and to the following (collectively, the "Assigned Patent Assets");

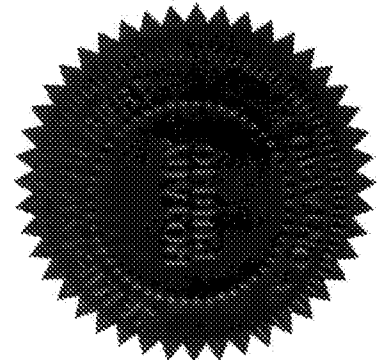
