


execute all divisional, continuation, and reissue applications, make all rightful oaths, and generally do everything legally required to aid ASSIGNEE, its successors and assigns, to obtain and enforce proper patent protection for the invention in the United States, it being understood that any expense incident to the execution of such papers or provision of such aid shall be borne by ASSIGNEE, its successors and assigns.
