Invention in the United States and all foreign countries, and the Assignors authorize and request the United States Commissioner of Patents and Trademarks, and any officials of foreign countries whose duty it is to issue patents, to issue all patents for the Invention to the Assignee in accordance with the terms of this Assignment;

AND, for the same consideration, the Assignors covenant that when requested, without charge to, but at the expense of, the Assignee, to carry out in good faith the intent and purpose of this Assignment; the Assignors will disclose all facts known to the Assignors relating to the Invention and its history; the Assignors will testify in all legal proceedings, and do everything possible which the Assignee may consider desirable for aiding in securing, maintaining and enforcing proper patent and intellectual property protection for the Invention, including but not limited to executing all rightful oaths, assignments, powers of attorney and other papers, as necessary, and the Assignors irrevocably appoint the Assignee as the Assignor's attorney in fact with power to execute on the Assignor's behalf any and all documents necessary to carry out the terms of this Assignment. The Assignors covenant with the Assignee that the Assignors have made no other assignment, grant, mortgage, license or other agreement affecting the rights and property conveyed here, and that the Assignors have full right to convey their entire right, title and interest as expressed in this Assignment;
