WE ALSO HEREBY authorize and request the Commissioner of Patents and Trademarks to issue all patents for said invention, or patents resulting therefrom to the said ASSIGNEE of our entire right, title and interest.

WE FURTHER HEREBY sell and assign to said ASSIGNEE, its successors, assigns and legal representatives the full and exclusive rights, title and interest to the invention disclosed in said application throughout the world, including, without limitation, the right to file applications and obtain patents, utility models, industrial models and designs for said invention in its own name throughout the world including all rights of priority, all rights to publish cautionary notices reserving ownership of said invention and all rights to register said invention in appropriate registries. We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, assigns and legal representatives.

WE HEREBY covenant that we have not and we will not execute any agreement in conflict herewith.

WE HEREBY further covenant, and agree to bind our heirs, legal representatives, and assigns, promptly to communicate to said ASSIGNEE or its representatives any facts known to us relating to said invention, to testify in any interference or legal proceedings involving said invention, to execute any additional papers which may be requested to confirm the right of the assignee, its representatives, successors, or assigns to secure patent or similar protection for the said invention in all countries and to vest in the assignee complete title to the said invention and Letters Patent, without further compensation, but at the expense of said ASSIGNEE, its successors, assigns, and other legal representatives.
