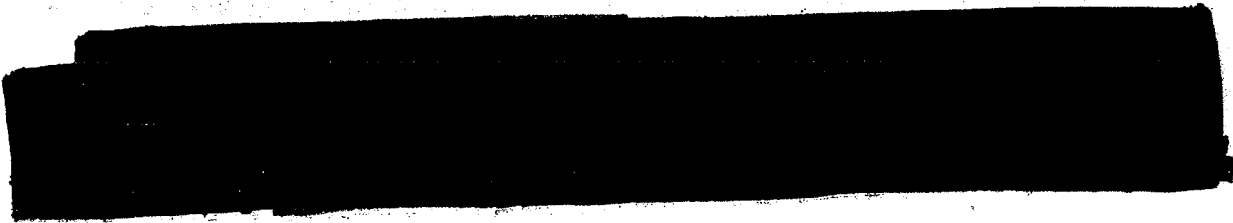
ASSIGNMENT AND AGREEMENT


