Notwithstanding anything to the contrary, the Assignor hereby assigns, transfers and conveys, nunc pro tunc, effective as of the last signature date, to the Assignee, and the Assignee hereby acquires and accepts from the Assignor, the entire right, title and interest throughout the world in the inventions and improvements which are the subject of the patent applications listed on the annexed Schedule A, and this assignment includes said applications, any and all United States and foreign patents, utility models, and design registrations granted for any of said inventions or improvements, and the right to recover for past infringement thereof, and to claim priority based on the filing date of said applications under the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purposes (collectively, the "Assigned Assets"); and Assignor authorizes the Assignee to apply in all countries in Assignor's name or in its own name for patents, utility models, design registrations and like rights of exclusion and for inventors' certificates for said inventions and improvements; and Assignor agrees for ourselves and our respective heirs, legal representatives and assigns, without further compensation to perform such lawful acts and to sign such further applications, assignments, Preliminary Statements and other lawful documents as the Assignee may reasonably request to effectuate fully this assignment.
