NOW THEREFORE, for and in consideration of the sum of Ten Dollars Australian (A\$10.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, we hereby confirm that we have sold, assigned, and set over and by these presents do hereby sell, assign and set over unto the said ResMed, and ResMed's legal representatives, successors and assigns, the entire right, title and interest in and to said Inventive Subject-Matter, said application, or any national and regional applications corresponding thereto, any continuation or divisional application, renewal, or substitute thereof, and any Letters Patent, and any reissue or re-examination thereof, to be obtained anywhere in the world, and we do hereby authorize and request the respective U.S. Commissioner of Patents and Foreign Commissioner of Patents to issue said Letters Patent and any reissue or re-examination thereof to be obtained anywhere in the world to the above-mentioned ResMed, consistent with the terms of this Assignment.




