ASSIGNMENT

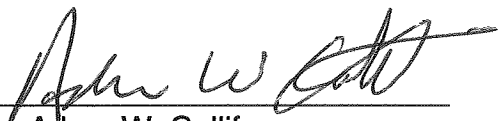

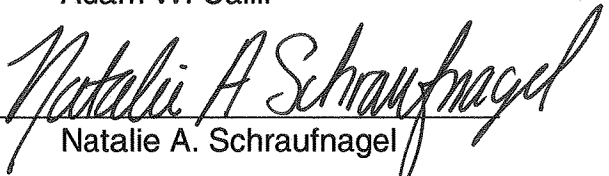
