
PATENT ASSIGNMENT

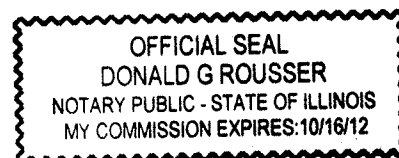
