## Patent Security Agreement

**Patent Security Agreement**, dated as of March 6, 2008 by Integrated Finance Limited, a Delaware corporation (the "Grantor"), in favor of LASALLE BANK NATIONAL ASSOCIATION (the "Secured Party").

### W I T N E S S E T H:

WHEREAS, the Grantor is a party to an Amended and Restated Guaranty and Collateral Agreement, dated October 19, 2007, (as amended, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement") made by the Grantors (including the Grantor) party thereto from time to time, in favor of the Secured Party.

NOW, THEREFORE, in consideration of the premises and to acknowledge and reaffirm the Collateral (as defined in the Security Agreement) that has been granted by the Grantor to the Secured Party, the Grantor hereby agrees with the Secured Party as follows:

SECTION 1. Defined Terms. Unless otherwise defined herein, terms defined in the Security Agreement and used herein have the meaning given to them in the Security Agreement.

SECTION 2. Grant of Security Interest in Patent Collateral. The Grantor hereby grants to the Secured Party a lien on and security interest in and to all of the Grantor's right, title and interest in, to and under all the following property, in each case wherever located and whether now owned or existing or hereafter owned, arising or acquired from time to time (collectively, the "Patent Collateral"):

- (a) each Patent and application for Patent of the Grantor listed on Schedule I attached hereto, together with any reissues, continuations or extensions thereof;
- (b) all goodwill associated with such Patents; and
- (c) all proceeds of any and all of the foregoing.

Notwithstanding any provision of this Patent Security Agreement to the contrary, the grant of security interest hereunder does not include any application for a Patent that would be deemed invalidated, canceled or abandoned due to the grant and/or enforcement of such security interest, including, without limitation, all U.S. Patent applications that are based on an intent-to-use, unless and until such time that the grant and/or enforcement of the security interest will not affect the status or validity of such Patent application.

SECTION 3. Security Agreement. The security interest granted pursuant to this Patent Security Agreement is granted in conjunction with the security interest granted to the Secured Party pursuant to the Security Agreement and the Grantor hereby acknowledges and affirms that the rights and remedies of the Secured Party with respect to the security interest in the Patent Collateral made and granted hereby are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.

In the event that any provision of this Patent Security Agreement is deemed to conflict with the Security Agreement, the provisions of the Security Agreement shall control.


SECTION 4. Counterparts. This Patent Security Agreement may be executed in any number of counterparts, all of which shall constitute one and the same instrument, and any party hereto may execute this Patent Security Agreement by signing and delivering one or more counterparts.

SECTION 5. GOVERNING LAW. THIS PATENT SECURITY AGREEMENT SHALL BE GOVERNED BY, AND SHALL BE CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
