WHEREAS, HEWLETT-PACKARD DEVELOPMENT COMPANY, L.P., a limited partnership established under the laws of the State of Texas and having a principal place of business at 11445 Compaq Center Drive West, Houston, Texas 77070, U.S.A., (hereinafter "Assignor") is the legal title holder of the patents identified in the attached Schedule 1;

IN WITNESS WHEREOF, Assignor has caused this Assignment to be executed by its authorized representative. The authorized representative hereby declares that all statements made herein of his or her own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under section 1001 of Title 18 of the United States Codes and that such willful false statements may jeopardize the validity of any patents related thereto.
