NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, **NOVA** hereby sells, assigns, transfers and sets over to **Jackam, Pierce and Jones** all right, title and interest in and to the said invention and U.S. patent application serial no. 11/504,828 (as well as all application(s) to which U.S. patent application serial no. 11/504,828 claims the benefit of) and any and all divisions, continuations, continuations-in-part and reissues thereof, and any and all applications filed outside of the U.S. which claim priority to U.S. patent application serial 11/504,828 as well as all patents of the United States and foreign countries which may be granted therefore including any reissues, divisionals, continuations, continuation-in-parts, renewals and extensions and the like (collectively, the "Patents"), the same to be held and enjoyed by **Jackam, Pierce and Jones** for their own use and benefit to the end of the term or terms for which said Patents of the United States or foreign countries are or may be granted or reissued.



divisional, continuation, or continuation-in-part applications or to secure a reissue of one or more of such Applications or Patents, or to file a disclaimer relating thereto, NOVA will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional, continuation or continuation-in-part applications, or such application for reissue and the procuring thereof, and for the filing of such disclaimer, without further compensation.
