PATENT AND INVENTION ASSIGNMENT

This **PATENT AND INVENTION ASSIGNMENT** ("Assignment") is made by **H. ROBERT TIFFANY**, a citizen of the United States of America, residing at 27 Cafferty Road, Point Pleasant, Pennsylvania 18950, (hereinafter referred to as "**Robert Tiffany**"), **TIFFANY AND TIFFANY DESIGNERS, INC** ("**Tiffany Designers**"), a corporation incorporated under the laws of the Commonwealth of Pennsylvania, with a principle place of business at 27 Cafferty Road, Point Pleasant, Pennsylvania 18950, and **AMERICAN LEATHER OPERATIONS, LLC** ("**American Leather**"), a corporation of the State of Delaware, having its principal place of business at 4501 Mountain Creek Parkway, Dallas, Texas 75236.

WHEREAS, the **Robert Tiffany** has co-invented certain inventions and improvements disclosed in a provisional patent application No. 60/329,021, filed on Oct. 12, 2001, in the United States Patent and Trademark Office, and a related non-provisional application for Letters Patent entitled Convertible Sofa-bed, which application was filed on June 13, 2002, under application Serial No. US 10/172,421 and thereafter issued as U.S. Patent No. 6,904,628 (collectively, "the Patent") on June 14, 2005;

WHEREAS, **Tiffany Designers** has employed **Robert Tiffany**; and

WHEREAS, **American Leather** has certain rights in the Patent and wishes to receive and clarify that it owns all rights to the Patent.

NOW, THEREFORE, for and in consideration of good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, **Robert Tiffany** agrees as follows:

- **Robert Tiffany**, by these presents, does sell, assign and transfer unto **American Leather**, its successors, legal representatives and assigns, **Robert Tiffany's** full and entire right, title and interest, if any, in and to: (i) all inventions and improvements disclosed and described in said application(s); and (ii) the Patent having issued therefrom.
- **Tiffany Designers**, by these presents, does sell, assign and transfer unto **American Leather**, its successors, legal representatives and assigns, **Tiffany Designer's** full and entire right, title and interest, if any, in and to: (i) all inventions and improvements disclosed and described in said application(s); and (ii) the Patent having issued therefrom.
- **Robert Tiffany** and **Tiffany Designers** also hereby assign all causes of action, claims and demands and other rights, for, or arising from, an infringement, including past infringements, of the Patent.
- **Robert Tiffany** and **Tiffany Designers** agree without further consideration that it shall, in connection with proceedings concerning the above mentioned invention and Patent, sign all papers and documents, take all lawful oaths, and do all acts necessary or required to be done for the recording, procurement, maintenance, enforcement and defense of said Patent; provided, however, that nothing in this Assignment shall otherwise alter covenants, rights and obligations by and between **Robert Tiffany**, **Tiffany Designers** and **American Leather** as set forth in agreements (including royalty obligations) by and between them, including provisions of the License Agreement entered into by **American Leather** and **Tiffany Designers** on October 1, 2000.

• This Assignment shall be effective at least as early as 28 January 2014.

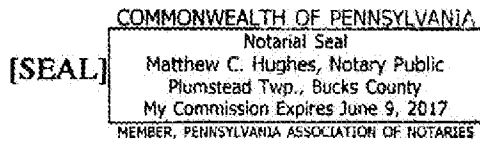

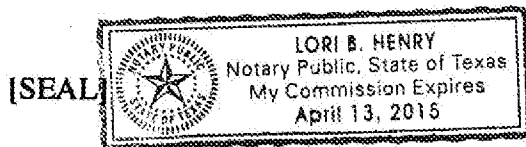
