- The right to claim priority rights deriving from the Patents and/or Applications;
- All causes of action and remedies related to the Inventions, Applications, and Patents (including, without limitation, the right to sue for past, present or future infringement, provisional rights under 35 U.S.C. sec. 154, misappropriation or violation of rights related to the Inventions, Applications and Patents);
- All rights to collect royalties and other payments under or on account of any of the Inventions, Applications and Patents; and
- Any and all other rights and interests arising out of, in connection with, or in relation to the Inventions, Applications and Patents.

Assignor will not sign any writing or do any act conflicting with this Assignment, and, without further compensation, will sign all documents and do such additional acts as Assignee, its successors, legal representatives and assigns deem necessary or desirable to: perfect enjoyment of the Rights; conduct proceedings regarding the Rights, including any litigation or interference proceedings; or perfect or defend title to the Rights. Assignor requests the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or issuances that may be granted upon any of the Rights in the name of Assignee, as the assignee to the entire interest therein.

The terms and conditions of this Assignment will inure to the benefit of Assignee, its successors, legal representatives and assigns and will be binding upon Assignor, its successors, legal representatives and assigns.
