WHEREAS, ASSIGNOR is currently conducting efforts which are currently incorporated in the technology addressed by the above referenced patent application entitled "Sex Specific Insemination of Mammals With Low Number of Sperm Cells" (the INVENTION);

WHEREAS, the ASSIGNOR has been and is under a continuing obligation to assign all rights related to the INVENTION to Colorado State University Research Foundation; and

WHEREAS, ASSIGNOR has agreed that ASSIGNEE shall own all patent rights to the above referenced invention;

1. The Assignor warrants that: he is the originator of all lawful rights, title, and interest to the Invention; these rights arose as a result of efforts at Colorado State University; he has conveyed no right, title, or interest in the Invention to any party other than the Assignee; and at the time of signing of this Assignment, he neither knows nor has reason to know of any outstanding claims, title, or interests against his interest in the Invention which are contrary to this assignment.

2. The Assignor, for good and valuable consideration, hereby sells, grants, transfers, and assigns to the Assignee its entire and exclusive right, title, and interest in and to the Invention. Such assignment includes, but is not limited to: all worldwide rights to make, use, and sell the Invention, and to file for foreign patents based upon the Invention, the entire right, title and interest in and to any improvements, divisions, substitutions, reissues, extensions, continuations, and continuations-in-part thereof, and all patents which may be granted thereon, and all related rights such as utility-model registrations, inventor's certificates and the like which may be granted under the laws of any foreign government.

3. The Assignor covenants that he will not execute any agreement in conflict with this Assignment. The Assignor on his behalf further covenants and agrees that he will testify in any legal proceeding, sign all lawful papers, execute all divisional, continuation, continuations-in-part, substitute, foreign, and reissue applications, make all rightful oaths, and generally do everything possible to aid Assignee or its licensee(s) or other successors in interests to obtain and enforce full protection and title in and to said Invention and related improvements in all countries without further consideration but at the expense of the Assignee.

4. This assignment shall be binding on all parties, their heirs, executors, administrators, successors, and/or assigns, and may be recorded before any governmental entity, including but not limited to the United States Patent and Trademark Office. The use of any singular shall include the plural and any plural shall include the singular as the case may be. The use of any gender term shall include be construed include any of masculine, feminine, or neuter term as the case may be.
