AUTHORIZE AND REQUEST the appropriate authority to issue or grant any and all patents granted on such improvements in and by jurisdictions to and in the name of the ASSIGNEE, and if a patent issued or granted by one jurisdiction may be registered or validated in another, to register or validate such patent at the request of and in the name of ASSIGNEE;

GRANT AND TRANSFER to the ASSIGNEE all right, title and interest in and to any and all sums that are or may be due prior to this assignment and that may become due in the future, resulting from or otherwise relating to the aforementioned patent applications, patents issued or granted therefrom, the improvements disclosed in any of them and exploitation of such improvements by or on behalf of ASSIGNEE or others, including without limitation damages, as well as royalties and revenues from sale of products, providing such sums are generated in or by jurisdictions;

WARRANT AND COVENANT that no assignment, grant, mortgage, license or other agreement or encumbrance affecting the rights and property herein conveyed has been or will be

made or entered into by the undersigned, and that the full right to convey the same as herein expressed is possessed by the undersigned;

COVENANT, when requested and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this assignment, to execute all divisional, continuing, substitute, renewal, reissue and all other patent applications relating to any and all such improvements; to execute all rightful oaths, declarations, assignments, powers of attorney and other papers; to communicate to the ASSIGNEE all facts and provide to the ASSIGNEE all documents and things known and accessible to the undersigned relating to such improvements and the history thereof, and testify as to the same in any interference, litigation or other proceeding relating thereto; and generally to do everything reasonably possible that the ASSIGNEE shall consider desirable for vesting title to such improvements in the ASSIGNEE, and to secure, maintain, defend and enforce valid and enforceable patent protection for such improvements;
