THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN CERTAIN U.S. PATENTS AND PATENT APPLICATIONS (the "*Patent Termination and Release*") dated as of February 3, 2014, from BANK OF AMERICA, N.A., in its capacity as administrative agent (the "*Administrative Agent*") pursuant to an Amended and Restated Guarantee and Collateral Agreement (the "*Guarantee and Collateral Agreement*") dated as of March 16, 2012 among GRAPHIC PACKAGING HOLDING COMPANY, a Delaware corporation, GRAPHIC PACKAGING CORPORATION, a Delaware corporation, GRAPHIC PACKAGING INTERNATIONAL, INC., a Delaware corporation, certain of its Subsidiaries, and the Administrative Agent.

WITNESSETH:

WHEREAS, pursuant to the Guarantee and Collateral Agreement a security interest (the "*Security Interest*") was granted by, among others, Graphic Packaging International, Inc. (hereinafter referred to as the "*Grantor*") to the Administrative Agent in certain collateral, including the Specified Patent Collateral (as hereinafter defined); and

WHEREAS, a Notice of Security Interest in Patents was recorded in the Patent Division of the United States Patent and Trademark Office on March 17, 2008 at Reel 020723, Frame 0748, including but not limited to those patents and patent applications set forth on Schedule I attached hereto; and

WHEREAS, a Notice of Security Interest in Patents was recorded in the Patent Division of the United States Patent and Trademark Office on March 21, 2012 at Reel 027902, Frame 0105, including but not limited to those patent applications set forth on Schedule II attached hereto; and

WHEREAS, the Administrative Agent has agreed to release its Security Interest in the Specified Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby agrees as follows:

1. Definitions. The term "*Specified Patent Collateral*", as used herein, shall mean the Grantor's right, title and interest of every kind and nature as of the date hereof in the patents and patent applications described on Schedule I and Schedule II attached hereto.

2. Release of Security Interest. The Administrative Agent hereby terminates, releases and discharges its Security Interest in the Specified Patent Collateral described on

Schedule I and Schedule II hereto without representation, warranty or recourse of any kind or nature. Except for the foregoing release of the Security Interest in the Specified Patent Collateral, no other lien or security interest on the Grantor's assets (including other patents and patent applications) in favor of the Administrative Agent is released or terminated.

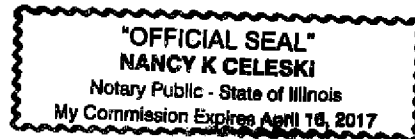
