This Assignment includes the right, in the sole discretion of the Assignee and without any economic benefits retained to the Assignor, to bring suit to recover for past damages, to settle infringement claims, and to license said Patent Rights.

The Assignor hereby authorizes and requests the Commissioner of Patents of the United States, or other proper governmental authorities in other countries, to issue to the Assignee, its successors and assigns, in accordance with this Assignment, any and all United States Letters Patent or other documents on said inventions or any of them disclosed in said applications.

The Assignor hereby agrees that the Assignee may apply for and receive foreign Letters Patent or rights of any other kind for said inventions, and may claim every priority right that is or may be predicted upon or arise from the Patent Rights; and that, when requested, without charge to, but at the expense of the Assignee, its successors and assigns, to carry out in good faith the intent and purpose of this Assignment, the Assignor will, for the United States and all foreign countries, execute all divisional, continuing, substitute, renewal, reissue, and all other patent applications or other documents on any and all said inventions; will execute all rightful oaths, assignments, powers of attorney and other papers; will communicate to the Assignee, its successors, assigns and representatives, all facts known and documents available to the Assignor relating to said inventions and the history thereof; will testify in all legal proceedings in which the Patent Rights may be involved; and will generally do everything possible which the Assignee, its successors, assigns or representatives shall consider desirable for securing, maintaining and enforcing proper patent protection for said inventions and for vesting title to said inventions and all applications for patents or related foreign rights, and all patents on said inventions, in the Assignee, its successors and assigns.

The Assignor hereby covenants with the Assignee, its successors and assigns that no assignment, grant, mortgage, license or other agreement affecting the rights and property herein conveyed has been made to others by the Assignor, and that full right to convey the same as herein expressed is possessed by the Assignor.






