Assignor hereby requests the appropriate governmental authority to issue any patent within the Patents to Assignee as Assignee of the Patents as the assignee of the entire interest therein. Upon Assignee's written request, Assignor hereby agrees to execute, at Assignee's expense, such additional form(s) of assignment for the foregoing patents and patent applications as may be reasonably required by the appropriate governmental authority for recordation of this Assignment.

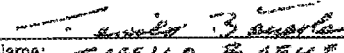

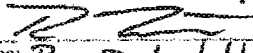
