## IN THE UNITED STATES PATENT AND TRADEMARK OFFICE

ASSIGNMENT

WHEREAS, We, Karl-Heinz RENZ, a German citizen, Birgit SCHLEIFENBAUM, a German citizen, Jens UHLEMANN, a German citizen, and Fouad SALEEB, a U.S. citizen, residing respectively at Nordstrasse 24c, 37603 Holzminden, Germany; Rte de la Versoix, 1299 Crans pres Caligny, Switzerland; Moltkestrasse 2a, 37603 Holzminden, Germany; and 4 Tanglewood Road, Pleasantville, NY 10570, U.S.A. (hereinafter ASSIGNORS), have made a certain invention entitled AROMA PARTICLES, for which we are making application for Letters Patent of the United States, which application has been executed concurrently herewith; and

WHEREAS, Symrise GmbH & Co. KG, a German corporation, located and doing business at Mühlenfeldstr. 1, 37603 Holzminden, Germany (hereinafter ASSIGNEE), is desirous of acquiring the entire right, title and interest in and to the aforementioned invention and the aforementioned application and any and all Letters Patent to be obtained on said invention and/or application;

BE IT KNOWN that for good and valuable consideration paid to us by said ASSIGNEE, the receipt and sufficiency of which is hereby acknowledged, we, the ASSIGNORS, by these presents do hereby sell, assign, set over and transfer unto said ASSIGNEE, its successors, legal representatives or assigns, the entire right, title and interest in and to the aforesaid invention in and for the United States and all countries foreign thereto; and in, to and under the aforesaid United States application and any corresponding foreign applications and any provisional, divisional, continuing, continuation-in-part, substitute or reissue applications or supplementary disclosures which may be filed on said invention in any country; and my right to file said foreign applications and claim priority under the provisions of the International Convention; and any Letters Patent of the United States or any foreign country issued or granted on said invention and/or said applications;



AND WE HEREBY covenant that I have the full right to convey the entire right, title and interest herein assigned and that I have not executed and will not execute any assignment or other instrument in conflict herewith;

AND WE HEREBY further covenant and agree to communicate to said ASSIGNEE, or its legal representatives, successors or assigns, any facts relating to said invention, including evidence for interference purposes or other proceedings, whenever requested, and to testify in any


interference or in any other legal proceeding, when requested, and to execute and deliver on request all lawful papers required to make any of the foregoing provisions effective; and to perform the aforesaid communicating, executing and delivering, without any payment except expenses and to perform the aforesaid testifying for reasonable compensation; and generally to do everything possible to aid the said ASSIGNEE, its successors, legal representatives or assigns to obtain and enforce proper patent protection on and for said invention in all countries, and likewise I make these provisions binding upon my heirs, legal representatives and/or administrators.
