ASSIGNMENT AGREEMENT

- (3) U.S. Patent Number 5,734,837, entitled, "Method And Apparatus For Building Business Process Applications In Terms Of Its Workflows," filed on January 14, 1994, and issued on March 31, 1998.
- (4) U.S. Patent Number 6,058,413, entitled, "Method And Apparatus For Utilizing A Standard Transaction Format To Provide Application Platform And A Medium Independent Representation And Transfer Of Data For The Management Of Business Process And Their Workflows," filed on May 13, 1997, and issued on May 2, 2000.
- (5) U.S. Patent Number 6,073,109, entitled, "Computerized Method And System For Managing Business Processes Using Linked Workflows," filed on December 12, 1996, and issued on June 6, 2000.

ASSIGNMENT:



4. Assignor hereby represents and warrants that Assignor is the owner of all rights, title, and interest in the Patents and that Assignor has the authority to assign the applicable Patents pursuant to this Assignment.
