**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN PATENTS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS**, dated as of August 16, 2013 ("Release"), is made by PNC Bank, National Association, as Agent ("Agent") in favor of Coby Electronics Corp., a New York corporation ("Grantor").

**WHEREAS**, pursuant to that certain Amended and Restated Revolving Credit and Security Agreement dated as of July 30, 2010 (as amended, restated, supplemented, modified, extended, renewed or replaced from time to time, the "Security Agreement") by and among the Grantor, Lenders, and the Agent, Grantor granted to the Agent, for the ratable benefit of the Lenders, a continuing security interest in and to all of its Collateral, including its patents and patent applications ("Patent Collateral");

**WHEREAS**, pursuant to the Security Agreement, Grantor executed and delivered to Agent, for the ratable benefit of the Lenders, the Notice of Grant of Security Interest in Patents dated as of July 30, 2010 ("Notice"); and

**WHEREAS**, the Notice was recorded at the United States Patent and Trademark Office ("USPTO") on December 13, 2005 at Reel 029459 Frame 0639.

**NOW THEREFORE**, in consideration of the mutual promises and undertakings set forth herein and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intention of being legally bound hereby, Agent, on behalf of the Lenders, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement or Notice.

**SECTION 2. Termination and Release.** Agent, on behalf of the Lenders, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the mortgage, pledge, and hypothecation and lien on and security interest in and to the right, title, and interest in, to, and under all the Patent Collateral, including, but not limited to, the foregoing listed on Schedule A attached hereto; and


(b) authorizes the recordation of this Release with the USPTO at Grantor's expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

IN WITNESS WHEREOF, the Agent, on behalf of the Lenders, has caused this Termination and Release of Security Interest in Patents to be duly executed as of the date first set forth above.
