WHEREAS: Stephen Schultz, an individual residing at 524 Bailey Road, West Henrietta, New York 14586, citizenship USA; Frank Giuffrida, an individual residing at 285 Chamberlain Road, Honeoye Falls, New York 14472, citizenship USA; and Robert Gray, an individual residing at 230 Bristol Street, Canandaigua, New York 14424, citizenship USA; (hereinafter referred to as ASSIGNORS), have invented a certain invention entitled: SYSTEM AND PROCESS FOR COLOR-BALANCING A SERIES OF OBLIQUE IMAGES, for which application for Letters Patent of the United States was filed on October 12, 2007, identified as U.S. Serial No. 11/871,740.

ASSIGNORS hereby covenant that no assignment, sale, agreement or encumbrance has been or will be made or entered into which would conflict with this assignment and sale, except the foregoing identified Assignment, executed, filed and recorded in error;

ASSIGNORS further covenant that ASSIGNEE will, upon its request, be provided promptly with all pertinent facts and documents relating to said application, said


invention and said Letters Patent and legal equivalents in foreign countries as may be known and accessible to ASSIGNORS and will testify as to the same in any interference or litigation related thereto and will promptly execute and deliver to ASSIGNEE or its legal representatives any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce said application, said invention and said Letters Patent and said equivalents thereof in any foreign country which may be necessary or desirable to carry out the purposes thereof.


