PATENT

WHEREAS, I, **Andrew F. Silverman**, hereinafter referred to as ASSIGNOR, whose post office address is set forth below, have invented and own a certain invention entitled:

SYSTEM AND METHOD FOR ALGORITHMIC TRADING STRATEGIES

for which a non-provisional patent application was filed with the United States Patent and Trademark Office on **June 7, 2005**, and assigned U.S. Serial No. 11/146,632.
