ASSIGNMENT

We, Larry J. Ashton, residing at 680 East 1600 South, Mapleton, Utah 84664; Michael G. Allman, residing at 668 South 1550 East, Spanish Fork, Utah 84660; Troy L. The right to file foreign patent applications on said invention in its own name, wherever such right may be legally exercised, including the right to claim the benefits of the International Convention for such applications.



This assignment and agreement shall be binding upon our heirs and legal representatives.






