WHEREAS, I/we the undersigned (hereinafter referred to as "Assignor"), have invented certain new and useful inventions as originally disclosed and/or claimed in U.S. Patent Application No. 13/589,807, entitled: "COLUMBARIUM CONSTRUCTION AND SHUTTER MOUNTING SYSTEM", filed August 20, 2012 (hereinafter, the "Application"); and

The said entire right, title and interest shall vest irrevocably in Assignee, and this assignment shall inure to the benefit of Assignee and Assignee's successors and assigns and shall be binding upon Assignor, and Assignor's successors and assigns.

Assignor covenants and agrees, upon request by Assignee, without additional compensation, but at no expense to Assignor, to execute or assent to foreign applications, and to execute all papers, assignments or other documents as requested by Assignee, and Assignor covenants to provide testimony by affidavit or otherwise on behalf of Assignee in any proceeding before the United States Patent and Trademark Office ("USPTO"), international or foreign patent authority, state or federal court, or other decision-making body, and that, in general, Assignor covenants to cooperate fully with Assignee as necessary or desirable to vest the enjoyment of, and to secure, perfect, maintain or enforce said entire right, title and interest in and to said Applications and any patents issuing therefrom or related thereto in and to Assignee. Assignor further covenants that no instrument has been executed that is contrary to this Assignment nor has Assignor taken any action contrary to this Assignment nor will Assignor do so in the future.

The Commissioner of Patents and the officials with comparable authority over patents in foreign countries are hereby authorized and directed to issue in the name of Assignee, or as otherwise directed by Assignee, any and all patents which may issue from said Application.
