

WHEREAS, Walker Digital Corporation, a Connecticut corporation having offices at One High Ridge Park, Stamford, Connecticut 06905 (hereinafter "WD") owns all rights, title, and interest in and to the inventions which form the subject matter of the issued patents and the patent applications identified in Schedule I attached hereto (all of said inventions, patents, patent applications, and any patents, certificates of invention or similar rights issuing from said patent applications hereinafter being collectively referred to as "WD Patent Rights", and the WD Patent Rights and all divisional, continuation, continuation-in-part, renewal, reissue, extension or other United States or foreign patent applications or rights based upon the WD Patent Rights, and any patents issuing from any of said divisional, continuation, continuation-in-part, renewal, reexamination, reissue, extension or other United States or foreign patent applications or rights based upon the WD Patent Rights being collectively referred to as "WD United States and Foreign Patent Rights");

WHEREAS, WD is the general partner in Walker Asset Management, a Connecticut limited partnership ("WHAM");

WHEREAS, WHAM owns all rights, title and interest in and to the inventions which form the subject matter of the issued patents and patent applications identified in Schedule II attached hereto (all of said inventions, patents, patent applications, and any patents, certificates of invention or similar rights issuing from said patent applications hereinafter being collectively referred to as "WHAM Patent Rights", and the WHAM Patent Rights and all divisional, continuation, continuation-in-part, renewal, reissue, extension or other United States or foreign patent applications or rights based upon the WHAM Patent Rights, and any patents issuing from any of said divisional, continuation, continuation-in-part, renewal, reexamination, reissue, extension or other United States or foreign patent applications or rights based upon the WHAM Patent Rights being collectively referred to as "WHAM United States and Foreign Patents Rights");

WHEREAS, the Jay S. Walker Irrevocable Credit Shelter Trust dated July 30, 1994 (hereinafter, the "Trust") is a limited partner in WHAM;

WHEREAS, concurrently herewith WD, WHAM and the Trust have entered into a Plan of Reorganization ("Plan of Reorganization") pursuant to which the Trust has contributed to WD the limited partnership interest of the Trust in WHAM so that WD becomes the sole owner of all assets of WHAM;

WHAM, acting through WD as general partner of WHAM, hereby confirms ownership by WD in, and does hereby assign and transfer to WD, all of its rights, title and interest in and throughout the United States, its territories and throughout the rest of the world in and to the WHAM United States and Foreign Patent Rights, including all causes of action, claims, demands and any other rights with respect to all past and ongoing acts of infringement of the WHAM United States and Foreign Patent Rights and to retain all revenues received from others for such acts of infringement of the WHAM United States and Foreign Patent Rights.
- 2. WD acknowledges its assignment, and transfer, and does hereby assign and transfer, to ASSIGNEE, all of its rights, title and interest in and throughout the United States, its territories and throughout the rest of the world, in and to the United States and Foreign Patent Rights, including all causes of action, claims, demands and any other rights with respect to all past and ongoing acts of infringement of the United States and Foreign Patent Rights and to retain all revenues received from others for such acts of infringement of the United States and Foreign Patent Rights.
- 3. WD hereby authorizes and requests the appropriate officers in the United States Patent and Trademark Office and in foreign Patent Offices, as appropriate, to issue to ASSIGNEE any and all patents, certificates of invention and similar rights that may be granted upon applications forming a part of the United States and Foreign Patent Rights, and to index this MASTER PATENT ASSIGNMENT against any and all of such patents, certificates of invention or similar rights, and any and all applications therefor, forming a part of the United States and Foreign Patent Rights.
- 4. WD further agrees for itself, its successors, assigns, and its legally bound predecessors to execute, without further consideration, any further legal documents, any further assignments, and any releases, reissues, renewals or other applications for patents and patent applications that may be necessary to complete the assignment of WD's interest aforesaid in and to the United States and Foreign Patent Rights.
