## RELEASE OF SECURITY INTEREST

Apple Inc., of 1 Infinite Loop, Cupertino, California 95014, United States of America (hereinafter "Apple") and Elpida Memory, Inc. of 2-1, Yaesu 2-chome, Chuo-ku, Tokyo 104-0028, Japan (hereinafter "Elpida"), entered into an Amended and Restated Security Agreement dated April 10, 2012 (hereinafter "Security Agreement"), in which Elpida granted Apple a security interest in certain assets, including a revolving pledge over the patents set forth in Schedule 2 of the Security Agreement.

Said Security Agreement was recorded in the United States Patent and Trademark Office on May 15, 2012 at Reel 028209, Frame 0477.

On July 23, 2013, Elpida provided Apple with the written request pursuant to Section 9.1 of the Security Agreement, and informed Apple that as all procedures contemplated by Section 11.3 of the Supply Agreement had been completed and the conditions of Section 9.1 of the Security Agreement had been satisfied, the Security Agreement was terminated.

Apple acknowledges receipt of Elpida's written request pursuant to Section 9.1 of the Security Agreement and agrees that all procedures contemplated by Section 11.3 of the Supply Agreement have been completed, the conditions of Section 9.1 of the Security Agreement have been satisfied, and that the security interest granted to Apple in the Security Agreement is hereby released and terminated effective as of July 23, 2013. Apple hereby authorizes and requests the Commissioner for Patents and Trademarks, the California Secretary of State, and any other appropriate government agency to record this Release of Security Interest.
