**DEED OF ASSIGNMENT**

This Deed of Assignment is between:

(i) **Xinpei Cao** (hereinafter referred to as the "Assignor", which expression shall include his successors and assigns), a Chinese national, of **14 The Rowans, Cambridge, CB24 6YU, United Kingdom** of the one part:

(ii) **Henkel Ltd.**, a British company of **Apollo Court, 2 Bishop Square Business Park, Hatfield AL10 9EY, United Kingdom**, (hereinafter referred to as the "Assignee" which expression shall include its successors and assigns) of the other part:

**WHEREAS**

- A. The Assignor is an inventor of an invention or inventions (hereinafter referred to as "the Inventions") described in United States patent application number **61/446,575** filed on **25 day of February 2011** (hereinafter referred to as "the Priority Application");
- B. The Assignor wishes to assign to the Assignee any rights that he has in or to the Inventions, the Priority Application, and any patents and patent applications relating to the Inventions and/or claiming priority from the Priority Application, and including but not limited to any continuations, continuations-in-part, divisional applications, reissues, revalidations, registrations, inventors' certificates, petty patents, utility models, supplementary protection certificates and renewals and extensions thereof (hereinafter referred to as "the Inventions, Patents and Patent Applications").

**NOW THIS ASSIGNMENT WITNESSETH THAT:**

1. The Assignor hereby assigns releases and conveys to the Assignee:
  - (i) the entire right, title and interest in and to the Inventions, Patents and Patent Applications; and
  - (ii) the full right to apply for and obtain patents or other similar forms of protection in respect of the Inventions in any part of the World; and
  - (iii) the right to claim convention priority from the Priority Application.
2. The Assignee accepts the assignment of:


- (i) the entire right, title and interest in and to the Inventions, Patents and Patent Applications;  
and
  - (ii) the full right to apply for and obtain patents or other similar forms of protection in respect of  
the Inventions in any part of the World; and
  - (iii) the right to claim convention priority from the Priority Application.
3. At the request and reasonable cost of the Assignees, the Assignor shall execute all such documents and do all such acts as may be necessary or proper for enabling the Assignee to perfect its right, title and interest in and to the Inventions, the Priority Application and the Patents and Patent Applications, and to prosecute, defend and enforce the Patents and Patent Applications, including but not limited to executing any application forms, confirmatory assignments, declarations, oaths, affidavits, technical reports and witness statements that may reasonably be required.
5. This assignment shall be governed by the laws of England.



