## ASSIGNMENT

FOR GOOD AND VALUABLE CONSIDERATION, the receipt, sufficiency and adequacy of which are hereby acknowledged, Global Polishing Systems, LLC, a Nevada Limited Liability Company with its principal place of business at 10624 S Eastern Ave., Suite A, Henderson, Nevada 89052, and Mark Wetherell, an individual (collectively, "GPS") do hereby:

SELL, ASSIGN AND TRANSFER to Arris Technologies, LLC, a Wyoming limited liability company, with its principal place of business at 14165 U.S. Highway 189-191, Bondurant, Wyoming 82922 ("ARRIS"), GPS' entire right, title and interest for the United States and all other territories throughout the world in and to any and all improvements which are disclosed in: U.S. Provisional Patent Application No. 61/609,089, filed on March 9, 2012 ("the '089 Provisional Application"), and U.S. Patent Application No. 13/794,516 filed on March 11, 2013 and titled LOW pH COMPOSITION FOR HARDENING CONCRETE AND ASSOCIATED METHODS ("the '516 Application") (the improvements disclosed in the '089 Provisional Application and the '516 Application, collectively, "the Improvements"), such applications and all divisional, continuing, reissue, substitute, renewal and all other applications for patent or the legal equivalent thereof, irrespective of whether any claim of priority to the '089 Provisional Application or the '516 Application is made, which have been or may be filed in the United States and all other territories relating to any of the Improvements; all original, reexamined and reissued patents or their legal equivalents which have been or shall be issued in the United States and all other territories on any of the Improvements; and specifically including the right to file applications for patents or their legal equivalents under the provisions of any convention or treaty and claim priority based on such applications (all of the foregoing, collectively the "Intellectual Property Rights");

AUTHORIZE ARRIS to apply for and receive any and all patents or their legal equivalents in any territory relating to any of the Improvements in its own name;

AUTHORIZE AND REQUEST the issuing authority to issue any and all patents or their legal equivalents in any territory granted on any of the Improvements to and in the name of ARRIS;

WARRANT AND COVENANT that no assignment, grant, security interest, license or other agreement or encumbrance affecting the rights and property herein conveyed, or ARRIS' rights to the rights and property herein conveyed has been or will be made or entered into by the undersigned, and that GPS possesses the full right to convey the same as herein expressed and to provide ARRIS with all right, title and interest in and to the Intellectual Property Rights, including, but not limited to, the Improvements, the '089 Provisional Application and the '516 Application;

COVENANT, when requested and at the expense of ARRIS, to carry out in good faith the intent and purpose of this assignment, to execute all divisional, continuing, substitute, renewal, reissue, and all other applications for patents or their legal equivalents relating to any and all of the Improvements; to execute all rightful oaths, declarations, assignments, powers of attorney and other papers; to communicate to ARRIS all facts and provide to ARRIS all



AGREE AND ACKNOWLEDGE that the SALE, ASSIGNMENT AND TRANSFER of rights and property set forth herein is and shall be IRREVOCABLE and BINDING upon the heirs, assigns, representatives and successors of GPS and EXTEND to the successors, assigns and nominees of ARRIS.

IN WITNESS WHEREOF, GPS has caused this instrument to be duly executed as of the 11<sup>th</sup> day of October, 2013.


