WHEREAS, Assignor owns all right, title and interest in and to the invention titled "Methods and devices for continuous transfer of particulate and/or fibrous material between two zones with different temperatures and pressures" comprised by the Patent Rights (as defined below in clause 1),

WHEREAS, Assignor desires to assign and transfer to Assignee all of Assignor's right, title and interest in and to the Patent Rights, and

WHEREAS, Assignor and Assignee has today also entered into a License Agreement regarding the Patent Rights

NOW THEREFORE, the Parties hereto have agreed as follows:

1. Assignment and transfer

1.1 In consideration of the sum of DKK 50,000, to be transferred to a bank account designated by the Assignor immediately following the execution of this Assignment, Assignor hereby assigns and transfers to Assignee, the entire worldwide right, title and interest in and to (collectively the "Patent Rights"):

1.1.1 all applications for pending patents and utility models as listed in Exhibit A to this Assignment as well as all present and future applications claiming priority from any of the foregoing applications,

1.1.2 all divisionals, continuations, continuations in part, substitutions, renewals, reissues, and other related applications which have been or may be filed anywhere in the world of the applications set forth in sub clause 1.1.1,

1.1.3 all patents and utility models (including reissues and re-examinations) which may be granted on the applications set forth in sub clauses 1.1.1 to 1.1.2 above, as well as all present or future patents and utility models claiming priority from any of the foregoing patents and/or utility models.

2. Documentation

2.1 Assignor agrees, without further consideration, to execute such documents and do all such acts and things that may be necessary or desirable to accomplish the

assignment and transfer the Patent Rights to Assignee upon Assignee's reasonable request.

3. Assignor's representation

- 3.1 Assignor represents and warrants that it owns all right, title and interest in and to the Patent Rights, and that it has the full power to enter into and perform its obligations under this Assignment and to transfer the Patents Rights.

4. Choice of law and Venue

- 4.1 This Assignment shall in all respects be governed by and construed in accordance with Danish law.
- 4.2 Any dispute between the Parties arising out of or in connection with this Assignment or any agreement made pursuant hereto shall be settled finally and conclusively by the Copenhagen Maritime and Commercial Court.

5. Counterparts

- 5.1 This Assignment may be executed in one or more counterparts, each of which shall be deemed an original and all of which may be taken together as one and the same Assignment.


