Pursuant to Section 251(c) of the General Corporation Law of the State of Delaware (the "DGCL"), Takeda California, Inc., a Delaware corporation, hereby certifies the following information relating to the merger (the "Merger") of Envoy Therapeutics, Inc. a Delaware corporation, with and into Takeda California, Inc.:

FIRST: The names and state of incorporation of each of the corporations constituent to the Merger are as follows:

FOURTH: Upon the effectiveness of the Merger, the Certificate of Incorporation of Takeda California, Inc., as amended to date, shall continue as the Certificate of Incorporation of the surviving corporation until further amended in accordance with the provisions of the DGCL.


