I HEREBY authorize and request the Director of the United States Patent Office and all offices of the country whose duty is to issue patents, to issue Letters Patent to the Assignee, as assignee of the whole right, title and interest thereto;

I HEREBY covenant that I have full right to convey the entire interest herein assigned, and that I have not executed, and will not execute, any agreement in conflict herewith;


