For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, we, Chiang,Hsuang-Chang, Ma,Chao-Tsung, Chen,Kun-Feng, Huang,Ying-Sun, have invented certain new and useful improvements as set forth in the specification of the application for the United States patent, which was filed on March 6, 2014, and assigned Serial No. 14/198,752, that has been executed by the undersigned prior hereto or concurrently herewith on the dates indicated and is entitled:

LED Luminaire Driving Circuit with High Power Factor

and we, the undersigned, hereby:
