WHEREAS, MICROCELL, INC. NOW, THEREFORE, in accordance with the laws of the State of Connecticut, Assignor has transferred and assigned and does hereby, transfer and assign to Assignees, *nunc pro tunc*, its entire right, title and interest in and to the Inventions and the Patent Rights, as owners of an undivided interest therein according to the aforesaid proportions, the same to be held and enjoyed by Assignees for their own use and enjoyment, and for the use and enjoyment of their successors, assigns or legal representatives, and each of them are granted, as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made; together with all claims for damages by reason of past infringement of said Patent Rights, with the right to sue for and collect the same for their own use, and for the use of their successors, assigns or other legal representatives.

ASSIGNOR hereby covenants and agrees that it has full right to convey its entire interest herein assigned, and that it has not executed and will not execute any agreement in conflict herewith.

ASSIGNOR further covenants and agrees that the terms, covenants and conditions of this Assignment shall inure to the benefit of Assignees, their successors, assigns, and legal representatives, and shall be binding on it, its successors, assignees and legal representatives.
