ASSIGNOR hereby covenants and agrees that he has full right to convey his entire interest herein assigned, and that he has not executed and will not execute any agreement in conflict herewith.

ASSIGNOR further covenants and agrees that the terms, covenants and conditions of this Assignment shall inure to the benefit of Assignee, his successors, assigns, and legal representatives, and shall be binding on Assignor, his heirs and legal representatives.
