#### PATENT ASSIGNMENT

This Patent Assignment ("Assignment") is entered into as of February 27, 2014, by and between DILL INC., a Delaware Corporation (the "Company"), and Yahoo! Inc., a Delaware Corporation ("Yahoo").

WHEREAS, Yahoo, Pickle Acquisition Corp., PTCH Merger Corp. ("PTCH") and DreamWorks Animation SKG, Inc. have entered into that certain Agreement and Plan of Merger, dated as of December 3, 2013, pursuant to which PTCH has become a wholly-owned subsidiary of Yahoo.

WHEREAS, pursuant to that certain Certificate of Merger of Pickle Acquisition Corp. with and into PTCH Merger Corp., dated as of December 3, 2013, PTCH has changed its name to that of the Company;

WHEREAS, the Company owns certain patents, patent applications, provisional patent applications and/or other patent rights, including, without limitation, those listed in Exhibit 1 of this Assignment; and

WHEREAS, the Company desires to assign to Yahoo, and Yahoo desires to receive, all of the Company's right, title and interest in and to such patents, patent applications and/or other patent rights.

NOW, THEREFORE, for good and valuable consideration given and received, the receipt and legal sufficiency of which is hereby acknowledged, the Company and Yahoo agree as follows:

The Company hereby:

- (A) irrevocably transfers, conveys and assigns to Yahoo:
  - (1) the entire right, title and interest, everywhere in the world to
    - (a) all patents, patent applications, and provisional patent applications owned by the Company, including, without limitation, the issued patents, patent applications, and provisional patent application set forth in Exhibit 1, and any patents later granted that are based on the patent applications and provisional patent application set forth therein.
    - (b) any patent applications or patents claiming priority to the items in (a) (including, but not limited to, continuations, divisions, continuations-in-part, substitutes, reissues, reexaminations, extensions and renewals thereof, together with all priority rights and counterpart applications under any existing or future international patent conventions, agreements or treaties),
    - (c) any patent applications or patents to which any of the patents or patent applications in (a) or (b) claim priority and any foreign counterparts to any patents or patent applications in (a) or (b),
    - (d) any other rights in the inventions described or disclosed in any of the patents and patent applications in (a), (b) or (c);

(all of the foregoing in (1), collectively, the "Assigned Patents");


- (2) all rights to causes of action and remedies related to the Assigned Patents, whether before or hereafter accrued, including, without limitation, the right to sue third parties for past, present or future infringement (including, but not limited to, damages and injunctive relief) of any of the Assigned Patents and the right to settle and retain proceeds from any such actions: and
- (3) all rights to receive royalties with respect to the Assigned Patents; and



- (C) agrees to deliver to Yahoo accurate copies of all material correspondence with counsel, in the Company's or its counsel's possession, relating to ownership, filing, prosecution, infringement, validity, or enforceability of the Assigned Patents, to the extent such has not already been delivered.
