## WORLDWIDE PATENT ASSIGNMENT

Assignment effective this 31<sup>st</sup> day of December, 2013.

ASSIGNORS, without reservation of any rights, hereby grants, sells, assigns, transfers and sets over to Assignee, its successors and assigns all worldwide and/or universal rights, title, and interest in and to the Patents, the same to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the terms for which Patents are granted or renewed as fully and entirely as the same would have been held or enjoyed by Assignor if this assignment and sale had not been made, including, but not limited to, (i) all worldwide patents, reissues, divisionals, continuations, continuations-in-part, renewals, reexamination certificates related by family to the Patents; and (ii) all rights and claims, including claims for damages, lost profits, royalties and benefits arising because of any past infringement of such Patents.

ASSIGNORS hereby authorize and request the Commissioner of Patents and Trademarks of the United States, and any Official of any country or countries foreign to the United States, whose duty it is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument;

ASSIGNORS hereby covenant and agree that ASSIGNORS have full right to convey the entire right, title and interest herein assigned, that such right, title and interest is unencumbered,

and that ASSIGNORS have not executed, and will not execute, any agreement in conflict herewith;

ASSIGNORS further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits and any other papers in connection therewith necessary to perfect such rights, title and interest in ASSIGNEE, its successors, legal representatives and assigns;


