ASSIGNMENT

and PHOENIX CONTACT GMBH & CO., KG, a German Kommanditgesellschaft or partnership having a principal place of business at Blomberg, Germany, and which, together with its successors and assigns is hereinafter called "International Assignee",

which US Assignee and International Assignee (collectively "Assignees") are desirous of acquiring the title, rights, benefits and privileges hereinafter recited, and of confirming the same or any part thereof heretofore acquired by Assignees.

Now, therefore, for valuable consideration furnished to me for this Assignment, receipt and sufficiency of which I hereby acknowledge, I hereby, without reservation:

1. Assign and convey to and confirm in US Assignee the entire right, title and interest in and to said inventions and discoveries in the United States of America said application for Letters Patent of the United States of America and any and all other applications for Letters Patent on said inventions and discoveries in the United States of America, including all provisional, non-provisional, divisional, renewal, substitute, continuation applications, and US nationalizations of international applications based in whole or in part upon said inventions or discoveries or upon said applications, and any and all Letters Patent and reissues and extensions of Letters Patent granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent;

2. Assign and convey to and confirm in International Assignee the entire right, title and interest in and to said inventions and discoveries worldwide except the United States of America, and any and all other applications for Letters Patent on said inventions and discoveries worldwide except the United States of America, including all provisional, non-provisional, divisional, renewal, substitute, continuation applications, and nationalizations worldwide except the United States of America of international applications based in whole or in part upon said inventions or discoveries or upon said applications, and any and all Letters Patent and reissues and extensions of Letters Patent worldwide except the United States of America granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent;

3. Authorize US Assignee to file or nationalize patent applications in the United States of America or designating the United States of America on any or all of said inventions and discoveries in my name or in the name of the US Assignee or otherwise as the US Assignee may deem advisable, under the International Convention or otherwise;

4 Authorize International Assignee to file or nationalize patent applications worldwide outside of the United States of America on any or all of said inventions and discoveries in my name or in the name of the International Assignee or otherwise as the International Assignee may deem advisable, under the International Convention or otherwise, including the right to file international applications designating the United States of America but excluding the right to nationalize such international applications in the United States of America;

5. Authorize and request the Commissioner of Patents of the United States of American to issue or transfer all said Letters Patent to US Assignee, as assignee of the entire right, title and interest therein or otherwise as US Assignee may direct;

6. Authorize and request the empowered officials of all other governments to issue or transfer all said Letters Patent to International Assignee, as assignee of the entire right, title and interest therein or otherwise as International Assignee may direct;

7. Warrant that I have not knowingly conveyed to others any right in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or discoveries; and that I have good right to assign the same to Assignees without encumbrance;

8. Bind my heirs and legal representatives, as well as myself, to do, upon either Assignees' request and at its expense, but without additional consideration to me or them, all acts reasonably serving to assure that the said inventions and discoveries, the said patent applications and the said Letters Patents shall be held and enjoyed by Assignees as fully and entirely as the same could have been held and enjoyed by me or my heirs or representatives if this assignment had not been made; and particularly to execute and deliver to Assignees all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by Assignees; to communicate to Assignees all facts known to me relating to said inventions and discoveries or the history thereof; and to furnish Assignees with any and all documents, photographs, models, samples and other physical exhibits in my control or in the control of my heirs or legal representatives and which may be useful for establishing the facts of my conceptions, disclosures, and reduction to practice to said inventions and discoveries.
