PATENT ASSIGNMENT AGREEMENT

NOW, THEREFORE, to all whom it may concern be it known that for and in consideration of at least U.S. \$1,000.00, and other good and valuable consideration, including consideration agreed upon among Assignors and Assignee pursuant to the Thunderbolt Asset Purchase Agreement and the receipt and sufficiency of which is hereby acknowledged, each Assignor has sold, assigned and transferred and by these presents does hereby sell, assign and transfer unto Assignee, its successors, assigns and legal representatives, Assignor's entire rights, titles and interests in and throughout the United States of America, its territories and all foreign countries, in and to the invention(s) described and/or claimed in the Patent Rights (the "Inventions"), together with Assignor's entire rights, titles and interests in and to the Patent Rights and such patents as may issue thereon, including but not limited to non-provisionals, continuations, divisionals, reissues, reexaminations, extensions and substitutions of patents and patent applications within the Patent Rights; the Inventions and the Patent Rights to be held and enjoyed by Assignee for its own use and behalf and for its successors, assigns and legal representatives, to the full end of the term for which said patents may be granted as fully and entirely as the same would have been held by such Assignor had this assignment and sale not been made; and each Assignor hereby conveys all of its rights arising under or pursuant to any and all United States laws and international agreements, treaties or laws relating to the protection of industrial property by filing any such applications for patent, including but not limited to any cause(s) of action and damages accruing prior to this assignment. Each Assignor hereby acknowledges that this assignment, being of Assignor's entire rights, titles and interests in and to the Inventions and the Patent Rights carries with it the right in Assignee to apply for and obtain from competent authorities in all countries of the world any and all patents by attorneys and agents of Assignee's selection and the right to procure the grant of all patents to Assignee in its own name as assignee of Assignor's entire rights, titles and interests therein;

AND, each Assignor hereby further agrees for itself and its respective successors, assigns, agents and legal representatives to execute upon request any other lawful documents and likewise to perform any other commercially reasonable acts which may be deemed necessary to secure fully the Patent Rights to Assignee, its successors, assigns and legal representatives, as well as to third parties at the request of Assignee including the execution of documents
