AND the assignor hereby agrees to execute, upon request, any and all further papers which may be necessary or desirable to enable the assignee, its successors and assigns, to file and prosecute any and all applications for foreign Letters Patent on said invention; and the assignor further agrees to execute any and all further papers which may be necessary or desirable to vest or perfect the title of the assignee, its successors and assigns, in and to the inventions therein disclosed, and in to any and all foreign Letters Patent and reissues thereof which may be granted upon foreign applications, including the

United States of America;

AND the assignor hereby authorizes and requests The Commissioner of Patents to issue each and every Letters Patent to be granted upon the aforesaid applications, including the United States of America, and upon any and all substitutes, divisions, and continuations of said foreign applications, and each and every reissue of said Letters Patent, to the assignee, its successors and assigns, as the assignee of the entire right, title and interest therein, in accordance with this assignment.


