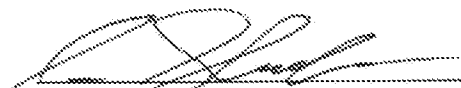
ASSIGNMENT OF PATENT APPLICATION

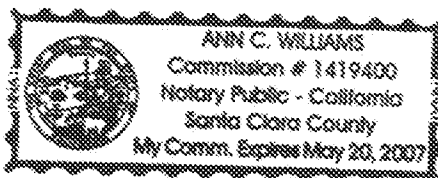

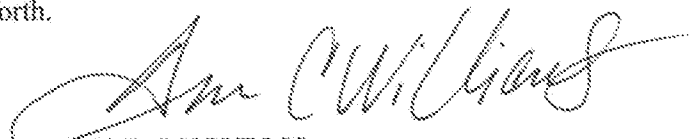
