DECLARATION OF MARCO BELLASIO REGARDING OWNERSHIP OF INVENTION



Dear Sir:

I, Marco Bellasio, having knowledge of the facts set forth herein, depose and say that:

1. I am a registered Italian attorney at law in good standing. I am authorized to practice law in Italy. I have been practicing Italian law for 9 years and have experience regarding intellectual and industrial property matters.
2. On information and belief, Italian law for industrial property matters is governed by the Industrial Property Code (c.p.i.).
3. On information and belief, Article 64 of the c.p.i. states that all economical rights derived from an invention made by an employee while in the employment of an employer and within the scope of his employment duties for the employer, are owned by the employer.
4. On information and belief, at the time of the invention that is the subject of the above-captioned patent application, Mr. Ivano Prandini was an Italian citizen residing in Italy, was an employee of Cy.Pag S.R.L., worked for Cy.Pag S.R.L as an employee at a facility located in Italy, and that the invention was within the scope of his employment duties for Cy.Pag S.R.L.
5. Accordingly, in my opinion, the rights in the invention are governed by Italian law.

6. On information and belief, the invention that is the subject of the above-captioned patent application was made wholly in Italy.
7. It is my opinion that under Italian law, all economical rights deriving from the above-named invention belong to Cy.Pag S.R.L.
8. Accordingly, it is my opinion that Mr. Prandini's rights in the above-captioned invention have been assigned to Cy.Pag S.R.L. by operation of Italian law.
9. I hereby declare that all statements made herein of my own knowledge are true and that all statements made on information and belief are believed to be true; and further that these statements were made with the knowledge that willful false statements and the like so made are punishable by fine or imprisonment, or both, under 18 U.S.C. § 1001, and that such willful false statements may jeopardize the validity of the present application or any patent issued thereon.
