ASSIGNMENT

WHEREAS, We, Patrick J. McCleer of 2439 Orchard Ave., Holland, Michigan 35802 and Richard K. Mains of 11333 Pinnacle Dr., Grass Lake, Michigan 49240 (hereinafter the "Assignors") have invented certain new and useful improvements in a SYSTEM AND METHOD FOR DETERMINING ROTOR SHAFT POSITION OF HIGH VOLTAGE PERMANENT MAGNET AC SYNCHRONOUS MACHINES USING AUXILIARY WINDINGS (hereinafter the "Invention") for which we have made a provisional application for patent of the United States, filed March 15, 2013, and identified as application no. 61/798,107 (hereinafter the "Application").

We do hereby request and authorize that any and all patent and any and all industrial property right, when granted, be issued in accordance with this assignment to the Assignee.

and foreign patents and any industrial property right for the Invention, and for maintaining and perfecting the Assignee's right to the Invention and any patent and industrial property right granted for the Invention, such as in cases of interference, derivation, opposition, post-grant review proceeding before the United States Patent and Trademark Office or any foreign intellectual property office, and litigation in the United States and any other country.
