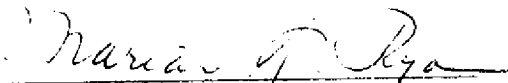
**CERTIFICATE OF CONVERSION TO LIMITED LIABILITY COMPANY**

5. This Certificate of Conversion shall become effective on June 18, 2010.

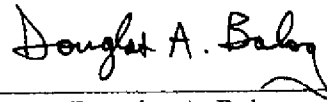

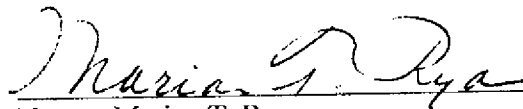
