Assignor hereby covenants and warrants that as of the date hereof she is the true lawful owners of the entire, right, title, and interest in said invention, applications, and patents which may issue pursuant thereto, that she has full right and power to convey the same, that the same are free and clear of all liens, charges, and encumbrances whatsoever, and that she has not executed and will not execute any agreement in conflict herewith.


