INTELLECTUAL PROPERTY ASSIGNMENT

This INTELLECTUAL PROPERTY ASSIGNMENT (this "Assignment") is effective as of September 6, 2012 (the "Effective Date") by and among, Dow AgroSciences LLC, a limited liability company organized under the laws of the State of Delaware, U.S.A ("DAS"), having a place of business at 9330 Zionsville Road, Indianapolis, Indiana USA and Viamet Pharmaceuticals, Inc., a corporation organized under the laws of Delaware ("VIAMET"), having a place of business at 2250 Perimeter Park Drive, Suite 320, Morrisville, North Carolina 27560 USA.

WHEREAS, DAS and VIAMET entered into an Option, Research, Collaboration and License Agreement dated as of November 1, 2010 (the "Agreement"), pursuant to which DAS agreed to assign certain patent applications to VIAMET; and

NOW, THEREFORE, in consideration of the above premises and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and with the intent to be legally bound, the parties hereto hereby agree as follows:

Effective as of the Effective Date, DAS hereby assigns, transfers and conveys to VIAMET all right, title and interest in and to the patent applications detailed in the attached Appendix, including, without limitation, all reissues, divisions, continuation, continuations-in-part, extensions thereof, and supplementary protection certificates related thereto.

DAS shall, at VIAMET's expense, take and shall cause its respective subsidiaries and affiliates to take, any and all additional actions as may be necessary or appropriate to effect the transactions contemplated by this Assignment. Such actions may include, without limitation, the execution of additional documents to record the assignments and transfers made in this Assignment and the filing of such documents with the appropriate domestic and foreign governmental authorities.
