PATENT ASSIGNMENT AGREEMENT

This PATENT ASSIGNMENT AGREEMENT is made as of April 19, 2005 by and between Alan Reid, an individual having his residence at 7 Kincora Drive, Clontarf, Dublin 3, Ireland (the "Assignor"), and Advanced Surgical Concepts Limited, an Irish company with a principal place of business at Unit 4, Sunnybank Centre, Upper Dargle Road, Bray Co., Wicklow, Ireland (the "Assignee").


In consideration of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and the Assignee hereby agree, acknowledge and declare as follows:

1. The Assignor hereby assigns, transfers, conveys and grants to Assignee, its successors and assigns, his entire right, title and interest (including, without limitation, the right to recover damages for past infringements) in and to (i) the patents and patent applications identified on Appendix A hereto, the inventions described or intended to be described therein, and in and to any continuations, continuations-in-part, divisionals, reissues, reexaminations, renewals, substitutes, extensions, any foreign counterparts thereof, and any other legal equivalent thereof that may be granted for such inventions worldwide and (ii) all inventions, developments or improvements made by the Assignor by or on behalf of the Assignor or the Assignee, its successors or assigns that are based upon, arise out of or are related to the items in (i), in all cases free and clear of any liens, claims, charges and encumbrances of any kind or nature whatsoever.
2. The Assignor hereby covenants and agrees that it will, at the request and cost of the Assignee, its successors or assigns and without further consideration, execute and deliver such other instruments of sale, transfer, conveyance and assignment (including, without limitation, any instrument used or useable for recording with any patent office the assignment by an inventor to the Assignor of any patents or patent applications identified on Appendix A hereto), and take such other action, as may reasonably be necessary or appropriate to more effectively transfer, convey, assign and deliver to, and vest in, the Assignee and its successors and assigns, good, clear, record and marketable title to the assets hereby sold, transferred, conveyed, assigned and delivered, or intended so to be, and to put the Assignee and its successors and assigns in actual possession and operating control thereof, to assist the Assignee and its successors and assigns in exercising all rights with respect thereto and to carry out the purpose and intent hereof.
3. Assignor covenants that Assignee and its successors and assigns will, upon request, be provided promptly with all pertinent facts and documents relating to the items in Paragraph 2 as may become known and accessible to the Assignor, and that the Assignor will, at the Assignee's cost, testify as to the same in any patent office proceeding, interference, litigation, arbitration or any other governmental, legal or quasi-legal proceeding related to the foregoing items, and that the Assignor will promptly execute and deliver to Assignee, its successors or assigns, or their legal representative, any and all papers, instruments or affidavits required to apply for, obtain, maintain, issue and enforce any and all rights to the foregoing throughout the world. The Assignor will

not be required to devote more than 5 working days in any year to its obligations under this Clause 3.


