ASSIGNOR, its executors or administrators, will at any time upon request, without additional consideration, but at the expense of the Assignee, its successors and assigns, executes such additional writings and do such additional acts as the Assignee, its successors and assigns, may deem desirable to perfect its enjoyment of this grant, and render all assistance in making application for and obtaining, maintaining, and enforcing the letters Patent or similar legal protection on the invention in any and all countries.

ASSIGNOR authorizes and requests that any Official of Office of any country or countries, whose duty is to issue patents or other evidence or forms of industrial property protection on applications as aforesaid, to issue the same to the said ASSIGNEE, its successors, legal representatives and assigns, in accordance with the terms of this instrument; and

ASSIGNOR covenants and agrees that he has full right to convey the entire interest herein assigned, and has not executed, and will not execute, any agreement in conflict herewith; and






